Ireland is a global centre for Financial Services. **Over 300 International Financial Services companies are operating from Ireland today**, including 22 of the world's top 25 financial institutions.



Banking in Ireland

- Ireland is internationally renown as a centre for Global Banking and is a recognised location for front, middle and back-office support activities, including operations and technology.
- Functions in Ireland include: corporate, commercial and wholesale banking, capital markets, global transaction services, corporate and structured finance, treasury/cash management, trading, digital assets, securitisation, trade finance, foreign exchange and many others. In addition, many banks in Ireland are also engaged in insurance, asset/ investment management, aviation financing and other activities.
 - Regulated institutions established in Ireland benefit from EU passporting opportunities, providing regulatory access to the EU single market. Post-Brexit, many banks selected Ireland as their post-Brexit EU headquarters to preserve access to the EU marketplace.
- Ireland is a strategic hub for Technology Innovation within the Banking sector. Global banks are increasingly establishing Innovation/R&D Hubs in Ireland, leveraging the convergence between Ireland's long-established Technology and Financial Services eco-systems to support their Digitisation and Transformation agendas. Citigroup, Bank of America, JP Morgan, TD Bank and SMBC are just some of the international banks who have created capabilities in AI, Data Analytics, CyberSecurity, Machine Learning, Quantum Computing, Cloud, RegTech and other technologies here. Innovations are typically deployed across their group operations globally from Ireland.
- Ireland has emerged as a leader in Sustainable Finance and ESG, with many global banks leveraging Ireland as a location to develop Sustainable Finance capabilities.

Citi has had a presence in Ireland since 1965. In 2016, Ireland became the headquarters of Citibank Europe plc, Citi's single EU-passported bank, with branches in 22 countries.

In Ireland, Citi operates a number of businesses including Banking, Markets, Services (Treasury and Trade Solutions and Securities Services) and Global Wealth (Private Bank).

Dublin is also home to one of Citi's global **Innovation Labs** and Citi's global **Artificial Intelligence Centre of Excellence**. In total, Citi employs c.2,900 people in Ireland.

J.P.Morgan

Dublin is a key banking and securities services hub for J.P. Morgan. It is an important payments location for the group which has its EMEA regional HQ for J.P. Morgan's Merchant Services business here.

Ireland is host to J.P. Morgan's largest technology hub in EMEA (ex-UK), with its Dublin **Designated Technology Hub** supporting cybersecurity, cloud services and other digital infrastructure for the group globally.

Dublin is also a growing centre for internal compliance and anti-money laundering related services while Cork is the headquarters of its Global Shares (a leading provider of employee stock plan management solutions globally) business. In total, J.P. Morgan employs c.1,500 people in Ireland.



BNP PARIBAS

BNP Paribas operates across multiple business lines in Ireland primarily in Corporate & Institutional Banking, Securities Services, Insurance, Re-Insurance and Real Estate advisory.

The bank provides an Integrated Bank solution to it's Corporate and Financial Institutions offering everything from Transaction banking to origination through to deal execution and asset servicing. BNP Paribas leverages Dublin as an EMEA hub for Supply chain financing and as its Global Headquarters for Hedge Fund Services. In total, BNP employs c.550 people in Ireland.

BANK OF AMERICA

Dublin is the headquarters of Bank of America's main EU banking entity, Bank of America Europe DAC.

The bank's Irish operations are engaged in a wide range of regulated and non-regulated activities including Global Banking and Markets, Global Transaction Banking Services, Leasing, Global Technology and Operations and Research & Development.

In total, Bank of America's Irish operation employs c.1,500 people in Ireland.



Barclays Europe is a European Bank headquartered in Ireland.

Through its offices in 10 European countries it operates Corporate Banking, Investment Banking, Markets and Private Banking businesses as well as Consumer Bank Europe, supporting corporate, financial and institutional and retail clients across the EU.

In total, Barclay's Irish operation employs c.300 people in Ireland.
